**Description:** For day after day high traffic and high gloss floors. Durable, stain and black heel mark resistance. Designed for both spray buffing and UHS burnishing systems. Easy to clean, easy to maintain.

### **Directions:**

#### STRIP AND RECOAT

- Before application, remove old coatings with Swish Clean & Green<sup>TM</sup> Floor Stripper.
- Pick up stripper solution using wet vacuum.
- Thoroughly rinse and neutralize floor. No sealer required except for new floors, very porous floors, or high traffic areas.
- Apply 3 to 4 coats of Swish Clean & Green™ Crystal Floor Finish.
- Allow at least 25 minutes after dry to touch between coats.

#### SCRUB AND RECOAT

- Scrub and recoat as required.
- Dry mop area.
- Scrub with a blue or green pad and Swish Clean & Green<sup>TM</sup> All Purpose Cleaner.
- Rinse and let dry.
- Apply 1-2 coats of Swish Clean & Green™ Crystal Floor Finish.

# **CLEANING - RESTORING GLOSS**

- Dry mop daily.
- Burnish/spray buff regularly recommend Aqua pad.

# **CLEAN AND SHINE**

Automatic Scrubber:

- Dry mop.
- Clean with Swish Clean & Green<sup>TM</sup> Neutral Floor Cleaner use a red pad.
- Allow floor to dry buff (red pad) / burnish (Aqua Pad). Mop and Bucket:
- Dry mop.
- Clean with Swish Clean & Green™ Neutral Floor Cleaner and damp mop.
- No rinse required.
- Let dry burnish (Aqua Pad).
