DILUTION:

Dilute 1 part of product in 200 parts of cool water (0.6 oz/gallon) for regular use; and 1:250 for light duty cleaning.

DIRECTIONS:

Clean with a brush, sponge or microfibre cloth. For glass & mirrors and shiny surfaces, wipe off with a dry cloth.

For strong or heavy malodors, follow cleaning by spraying ES 100 on sides of urinals, toilets, and surrounding floors and any surface where urine or fecal matter could be present.

1. Before use, thoroughly clean the container, (eg. pails, mop buckets or spray bottles) while always using new, or dedicated to this product, cleaning supplies such as a mop head or towel.
2. Mix proper dilution and fill the container. Stir well.
3. Do not add bleach to the product or other cleaning agents.
